WHEREAS, the Agent and the Grantors, entered into the Security Agreement;

WHEREAS, under the Security Agreement, the Grantors, among other things, granted to the Agent security interests in such Grantors' right, title and interest in the United States and foreign intellectual property rights identified on <u>Schedule A</u> attached hereto (the "<u>Intellectual Property</u>"), as security for the obligations of the Grantors under the Security Agreement;

WHEREAS, the Agent recorded an Amended and Restated Intellectual Property Security Agreement with respect to the Intellectual Property listed on <u>Schedule A</u> on July 20, 2016, in the United States Patent and Trademark Office ("<u>PTO</u>") at Reel 5838, Frame 0001;

WHEREAS, pursuant to that certain Payoff Statement, dated as of December [22], 2020, among the Grantors and the Agent, the Agent has agreed to terminate, release and discharge the security interests with respect to the Intellectual Property.

NOW THEREFORE, the Agent, on behalf of itself as agent, and on behalf of the Lenders, agrees as follows:

1. Defined terms used but not defined herein shall have the meanings attributed to such terms in the Security Agreement.

- 2. The Agent hereby:
- (i) releases all liens and security interests with respect to the Intellectual Property;
- (ii) re-assigns and releases to the Grantors and terminates all right, title and interest that the Agent has in and to the Intellectual Property and all proceeds of the foregoing; and all general intangibles associated with the foregoing, including without limitation, all goodwill associated in any way with such Intellectual Property; and all the rights to sue for past, present and future infringements, and all rights corresponding thereto associated with such Intellectual Property;
- (iii) terminates the power of attorney granted to the Agent, for the benefit of itself and for the benefit of the Lenders, under the Security Agreement;
- (iv) waives and relinquishes all the Agent's rights, powers, privileges, and remedies with respect to the Grantors under the Security Agreement with respect to the Intellectual Property; and
- (v) releases the Grantors and their respective successors and assigns from all covenants, obligations, liabilities, and warranties under the Security Agreement.
